

Description of Project:

The purpose of the project is to improve evacuation and ingress/egress routes throughout SMC public roadways. The project would thin or remove hazardous vegetation encroaching or overhanging critical roadways and power lines in the wildland urban interface, (WUI). This will reduce heat, flame, ember, and smoke impingement on roadways and nearby structures, which would enable safer and more efficient evacuations for residents and improve access for emergency personnel and firefighting apparatus. Project to be completed by June 30, 2023.

Along .75 miles of Sandhill Rd remove ladder fuels and brush encroaching into roadway. Remove 2 small eucalyptus trees. Chip material and remove chips and large trunk debris offsite.

Along 100 feet of Palomar Dr. remove 2 eucalyptus extending over the power lines, remove 3 acacia encroaching into the roadway. Chip material and remove chips and large trunk debris offsite.



The specific sections which apply are 15301(c) road maintenance, 15301(h) maintenance of existing landscape native growth, and 15304(i) Class 4 minor alteration to land, including fuel management.

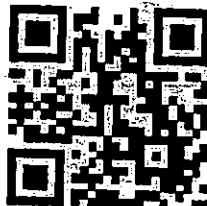
